

#### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is signed on 21<sup>st</sup> September, 2017 between Engineering Council of India (ECI) having its registered office at 1304 Hemkunt Chambers, 89, Nehru Place, New Delhi-110019 hereinafter called the "First Party" (which expression shall, unless repugnant to the context, includes its authorized Member Associations, its successors and assignees of the First Party).

#### AND

Samrat Ashok Technological Institute (Engineering College) SATI Vidisha having its registered office at Civil Line, Vidisha, Madhya Pradesh hereinafter called the "Second Party" (which expression shall, unless repugnant to the context, include its successors, and assignees of the "Second Party")

#### PREAMBLE:

WHEREAS ECI is registered as a Not-for-profit Society under the Societies Registration Act, 1860 and is the Apex body of the engineering profession in India. It is mandated to work for the advancement of engineering profession in various disciplines and for enhancing the image of engineers in society, by focusing on quality and accountability of engineers. Among its founding members are Planning Commission (Now NITI Aayog), All India Council for Technical Education (AICTE), National Board of Accreditation (NBA), Central Public Works Department (Ministry of Urban Development), Department of Commerce (Ministry of Commerce & Industry), Dept. of Secondary and Higher Education (Ministry of HRD), Department of Scientific and Industrial Research, Council of Scientific & Industrial Research & several other Professional Institutions.

WHEREAS Samrat Ashok Technological Institute (Engineering College) (SATI) is to enhance technical education in the State.

All India Council of Technical Education (AICTE), a statutory body through an Act of Parliament 52, in 1987, for regulating and controlling Technical Education in India, has made ECI the authorized body to facilitate Hands-on training and/ or arrange for "internships" to technical stream students in all disciplines of engineering and management in AICTE approved technical educational institutions for their Continuing Professional Development (CPD).

WHEREAS, the First Party has launched a scheme for industrial training students of all streams of engineering education at degree levels for engineering and graduation and post-graduation levels for management. These programs would be controlled and modulated by ECI through its Member Associations (MA).

AND WHEREAS, the Second Party is desirous of tying up with the First Party under the said AICTE-ECI scheme for Training, and agrees to for carrying out the above mentioned training for its students with its own resources/or arrange through appropriate industry relevant to the requirement of the concerned student.

NOW, THE FIRST AND SECOND PARTIES herein and hereby agree to collaborate for the purpose of initiating, developing and implementing programmes of training of Engineering and Management students at degree level for engineering and/ or graduate and Post graduate levels for management student's with the Second Party agreeing to utilize its resources for conducting such training.

#### RESPONSIBILITIES:

#### A. FIRST PARTY:

The First Party (subject to payment of relevant fees & dues by Second Party or their students) to First Party and / or its authorized Member Associations) shall coordinate and modulate the industrial internship of the students of the second party for a period of 5 years initially, extendable to such periods as are approved by the first party from time to time.

The First Party is responsible for providing the syllabi, curricula of the programs to be offered by the Second Party.

The Second Party will not add to, subtract from or substitute all or any of the above at a future date or alter the duration of training and/ or number of trainees in its training courses without the approval of the First Party. In all matters concerning training, testing and certification under this scheme, the First Party shall provide the systems and procedures.

The first Party shall conduct examinations or jury interviews, of candidates trained under the approved programs and issue certificates to the successful ones. The Second Party shall ensure that due cognition is given to this process, by not permitting award of degree until this stage is cleared. Its authorized Member Associations shall discharge the obligations of the first party.

#### B. SECOND PARTY

The Second Party shall ensure that all training is conducted in conformity with the standards, norms, methods approved under the First Party or its Member Associations scheme for training and education. The Second Party shall also ensure that all training is conducted only as per courses approved by the First Party.

The Second Party shall ensure that the fees are paid to the First Party and /or their authorized Member Associations as prescribed by the First Party from time to time.

The Second Party shall ensure the provision of minimum number of trainees, resources of space, manpower, equipment, material and other facilities as directed by the First Party. In this connection, the Second Party will furnish relevant information as required by the First Party and facilitate initial and subsequent inspection of their facilities.

#### **TERMINATION**

This MoU could be terminated by giving a notice of one year or the conclusion of ongoing programs, whichever is later, from either side, however the first right of refusal / acceptance shall be that of the first party.
